# **Proposal on the Revision of the By-Law of JFES**

The revision of the By-Law of Japan Formation Evaluation Society was proposed in the board meeting. The proposed revision is sent together with this newsletter. Please review those changes, and let us know if there is any comment. This revision would be voted and approved at the Annual Business Meeting of JFES during the 13th Formation Evaluation Symposium of Japan. The approved revision will then be submitted to Board of Directors of SPWLA for the final approval.

The main points to change are:

- Name of the chapter is defined as JFES, and change is made for the contact address.
- Number of board member the wording 'up to ten' is removed.
- Frequency of chapter meetings change from bi-monthly to quarterly.
- The term of officers shall begin on the first day following the Annual Business Meeting of the JFES and end at the close of the next Annual Business Meeting.
- Membership clauses are modified according to the recent SPWLA rule change and current situation.
- If there is no multiple candidates in the Election of Officers, the officers will be approved at the Annual Business Meeting. without voting.
